

The Giving Tree: A Cherished Tradition

This past December marked the 14th year that members of First Church fulfilled the Christmas wishes of area foster children.

Once again, Therese Ramseyer coordinated with Children's Hospital of Wisconsin Community Services to obtain the names of 100 children in the foster care, respite care and counseling programs. After organizing the information, Therese coordinated with First Church, Kohl's Department Store and others interested in donating gifts. She notes that First Church is the single, largest source of Christmas presents for the children.

Barb Dunham has been at the helm of the church's effort since our first year of our participation. She prepares the hanging gift tags, maintains a master list, and makes sure gifts

brought to the church are clearly marked with the appropriate tag. She keeps a running record of all gifts received and records them on the master list. She also organizes all gifts into boxes for easy transport. This year, First Church also served as the central collection point for Kohl's. Barb also coordinates the pick-up with our contact at Children's Hospital. This year, because of

COVID-19, the gifts were picked up by the individual case workers across several days, instead of in one fell swoop!

It's a big project with a lot of moving parts . . . and very worthwhile. Our thanks to Therese, Barb and all gift donors who made sure 100 foster children found a present under the tree on Christmas morning.



Minutes of the 177th Annual Meeting

Meeting was called to order at 10:47 AM by Moderator Jim Harris. Moderator Harris invited the congregation to read the Covenant in unison. Reverend Trump followed with the Invocation.

Approval of the Minutes from the 176th Annual Meeting

- Moderator Harris pointed out the 176th Meeting Minutes had three amendments needed.
 - Page 1. Approval of minutes should have been for the 175th Annual Meeting.
 - Page 5. Should read '176th Annual Meeting of First Congregational Church of Wauwatosa adjourned at 11:41 AM'
 - Page 4. Jeff Daly was nominated to serve on the Congregational Care Board-NOT Jim Daly.
 - Moderator Harris asked for a motion to accept the 176th Annual Meeting Minutes with amendments. Motion was 2nd. Motion Passed Without Exception (PWE).

Treasurers Report: Report given by Rick Nowacki

- Schedule I Statement of Financial Position
 - At the end of 2019 the church has \$2,635,581 in total assets.
 Net assets were \$2,330,491 which increased approximately \$257,000 from 2018. Much of the increase is due to investment growth.
 - Money Market and savings saw an increase mostly due to the Capital Campaign. The \$227,519 liability entry is money collected to be used on the Capital Campaign Projects.
 - Accts Payable at year end was \$18,113.
- Schedule II Operating Statement
 - Pledge Income for 2019 ended at \$481,912 which represented 98.2% of the budget. This is down \$74,189 when compared to 2018.
 - Total Income for 2019 was \$676,512 which was \$28,418 above budget. Pledge commitments for 2019 were projected to be down but \$55,693 in Individual Contributions made up a portion of the shortfall.
 - Total Expenditures of \$631,071 were \$17,023 below budget and lower than 2018 by \$41,086
 - Year End Net Income was \$45,441 and will be carried over as budgeted income for 2020.
- Schedule III Operating Fund Expense Detail
 - This schedule further breaks down expenditures for each Board. For 2019, each Board kept their costs under budget.
 - Total Operating Expenditures were \$574,249 which represented 97.5% of the budget.
 - Benevolences are routinely targeted to be 10% of our total operating expenditures and this year they totaled 9.9%.
- Schedule IV Statements of Changes in Fund Balances
 - Fund balance at year end was \$2,330,491 which increased \$256,633 over the previous year. These funds are primarily held in the Congregational Investment Trust which yielded a net return of 20.24% for 2019 resulting in investment income of \$349,246.
 - \$21,282 was received in gifts and bequests.
 - Disbursements totaled \$57,628. Facility Renewal disbursements are for large building expenses/repairs. Program Development disbursements are directed to the new Saturday Service, Communications and marketing outreach. Memorial & Special Gift disbursement was primarily a transfer of funds donated early in the Capital Campaign before the current money market was established.
- In closing, Rick thanked Jim and Cindy Walsh for their help

throughout the year and the office staff for compiling the reports each month.

Board of Stewardship: Report given by Mike Huitink

- Mike first extended thanks to the Stewardship Board.
 - A number of donors were lost, and pledges were down in 2019
 - The annual pledge drive was just completed and pleased to report the pledge campaign finished positive. 168 pledge came in. Average pledge went up to \$3,152.
 - 2020 will pose the same challenges as we saw in 2019.
 - As for our benevolences, Greater Tosa Interfaith (GTI) ceased operations in 2019. In an effort to redistribute the money GTI was receiving, the Board is asking church members where they might like to see the money go. Perhaps there is an organization that our members support that could benefit from our gifting. One Hope 27, supported by Carrie Sgarlata, was looked at in 2019 and has benefitted from our giving.

Budget and Finance: Report given by Hank Collis

- Thanked the members of the Committee and is pleased to
 present a balanced budget. The Committee was able to increase
 budget amounts in some areas and refund our Deferred
 Maintenance Plan. The Deacons budget increased so they could
 continue their work with the 4 o'clock Saturday service and the
 budget for our outreach community relations also increased.
- Other notables:
 - 400th Congregational Anniversary coming up and there is a committee associated with this, planning events for our membership.
 - Staff for the first time in a few years, received raises.
 - Projected revenue from Pledge Campaign is approximately \$40,000 more than last year. Total budget will be \$687,841 for 2020.
- As a member, please do what you can to pay your pledges throughout the year.
- A call for questions was made. None were presented.
- Hank asked for a motion to accept the 2020 budget as presented. Motion was accepted. Motion PWE.

Capital Campaign: Report given by John Griffith

- Recapping the two projects: The Elevator & the Nave. With an
 estimated cost for both projects to be approximately \$700,000,
 the goal is to have the congregation raise 50% of that cost with
 the balance coming from other areas. At present the projects
 have donations/pledge commitments of \$489,780. At present
 there is approximately \$227,000 in the bank after spending
 some monies on initial engineering and developmental fees.
- Trustees would be moving forward with the elevator project first as this is viewed as a more immediate need. Hoping once bank balance is around \$300,000 the project can commence.

Elevator Update: Report given by Bill Edens

- Bill began by sharing some historical data of the church. The first church was built on this property in 1853. The land was donated to the church by Charles Hart for \$50. The church was built for \$3347. The Nave is 100 years old and built at a cost of \$118,258.
- There is no formal timeline yet. About 45% has been pledged or paid into the Capital Campaign. Estimates are hopeful that by the end of 2020, there could be 70% of funds on hand and perhaps we could begin the elevator in the spring of 2021.
- · Architectural planning, electrical and mechanical drawings

are continuing. Existing building drawings do not necessarily match actual structure. A survey of asbestos on all four floors has been completed around the elevator shaft. Building of elevator could cause disruptions around the church.

 Please keep your financial commitments up to date to keep the project on schedule.

Recognition of Retiring Officers, Board, and Committee Members: Report given by Jim Harris

- Jim thanked the retiring Board and Committee members for their commitment and service to the church.
 - Jim announced each individual by board/committee.

Election Presentation of Nominees: Report given by Jim Harris

- Moderator Harris announced there are two openings yet to be filled: a position on Deacons and a position on Fellowship.
 - Jim asked for a motion to accept the slate of candidates.
 The motion was 2nd. Moderator Harris asked for any nominations from the floor, and none were advanced. A vote was called. Motion to accept the slate of candidates PWE.
 - Accepted candidates were announced.

Congregational Home Report: Report given by Kris Sprtel

- Pleased to announce 2019 was a good year.
- Received an excellent customer satisfaction survey rating. Also had a perfect annual state inspection. Maintained their 5-star Medicare survey rating.
- Updating the facility with cosmetic projects. Also working with the City of Brookfield on proposed future additions to the Memory Care Assisted Living and Wellness Center.

NACCC Report: Report given by Marianne King

- NACCC Conference was another positive experience.
- In 2019, the NA (National Association) provided over \$600,000 to Congregational churches around the country and the world in such places as Myanmar, Mission Mazahua in Mexico and churches in Argentina. The NA also gives approximately \$50,000 annually to places that experience natural disasters.
- 20-25 churches use the NA's pastoral search program annually
- The Congregationalist publication has an annual national circulation of approximately 7,000.
- Celebrating the 400th anniversary of the Mayflower's landing at Plymouth Rock this year.

Moderator's Comments: Report given by Jim Harris

• Jim reminded the congregation of the challenges that the

- church faced in 2019 and thanked the congregation for rising to those challenges.
- The office has been reorganized with Jill taking on the role of Financial Secretary and Marianne joining as Office Coordinator. Mark Lund has also accepted more responsibilities with caring for the facility. Jim also offered a thank you to Cindy Walsh for guiding us through this transition.
- The Communications Committee led by Scott Mason made great strides in implementing social media and direct mail marketing to tell others about our church.
- Saturday Under the Steeple is a wonderful service led by Peggy Griffith, Pat Reddy & Maddie Sgarlata.
- Community Through Understanding led by Jim Santelle has presented a number of events to engage our members with other communities.
- Christian Education led by Tonia Wallner & Jim Santelle have worked to engage our youth with the church and the community.
- Through the generosity of our congregation, the Stewardship Board and Capital Campaigns have moved in positive directions.
- Thank you to Bill and Barry for their spiritual leadership,
 Marianne King for her guidance as Past-Moderator and to
 Hank Collis for his work throughout the year.
- In closing Moderator Harris thanked all who served on the Boards and Committees. He also reminded that while the church will continue to face challenges in the future, each of our members is what will carry us forward.

New Business

- One Hope 27: Report given by Carrie Sgarlata
 - Carrie shared an update on the organization and thanked the congregation for the support they have given to this organization.

Moderator Harris called for a Motion to adjourn the 177th Annual Meeting of First Congregational Church Tosa. Motion was 2nd. The meeting adjourned at $11:34^{\rm am}$.

The meeting concluded with the congregation singing "Go Now in Peace."


We hope each of you had a safe, healthy and joyous Christmas.

A Note From Pastor Barry

What New Year's Resolutions can we consider when it seems that every day is Blursday? In 2021 do we even dare make any promises to ourselves? (I have a suggestion later in this article, but first...) We are almost in the middle of our Wisconsin winter. Darkness arrives earlier. We are probably willing to spend less time outdoors in frigid weather. Seasonal Affective Disorder (SAD) affects many. Because we are trying to avoid Covid-19, the flu and the common cold, we socialize less, and when we do gather, even with friends, it is different than before. Elbow bumps cannot replace hugs. Visits with doctors may be virtual. Restaurant kitchens now package for



more take-outs than for eat-ins. Airline travel is not the same. And, as one pundit mentioned, even the current trend in "open-concept" homes may be changing because, after having spent ten months of 24-7 family time, we need to find a door we can close to be alone. After 2020, we are uneasy. It seems like a perfect storm with strong winds howling around us!

So, what do we do? Even though Jesus tells us not to be anxious, we are. How can we combat worry? Experts suggest writing down our anxieties. The process of writing helps us to see what we are concerned about. Some of what we write may be significant to us; some may not. But seeing it laid out in front of us in black and white may help us get unstuck. Then we can better understand what Jesus meant when he wisely explained, "... do not worry about tomorrow, for tomorrow will bring worries of its own. Today's trouble is enough for today." If only we paid more attention to His advice!

When Jesus reminded us that we are to love our neighbor as we love ourselves, he meant it. We are to take care of ourselves so we can know Him better, and also do His work on this earth. Proper sleep and exercise, proper eating and grooming, are all important, as is safe social interaction for self-care. Even though Jesus often prayed to His Father while He was alone, He was an extremely social person. He combined self-care with community as He worked to bring about God's Kingdom on this earth.

Is it possible to keep joy in our lives in January during a pandemic? I believe it is. Keep a routine. Having a schedule such as "Monday is bed sheet changing day" is not just Grandma's rule, it helps establish a routine. In Wisconsin we already have Taco Tuesdays, Thursday Burger Nights, and Friday Fish Fries! (Yikes, I just realized my fixation on food!) We have to take care of ourselves because we are in for a longer haul than we initially thought. "Love . . . as you love yourself . . ."

If every day seems it is a Blursday, do I offer a suggestion to consider for a New Year's Resolution? Yes, it is to accept change. Why? Because change is inevitable. I remember when people were saddened when a fire destroyed parts of Yellowstone National Park. Yet two years later those same individuals were amazed at the new growth. People don't like change. In the Book of Acts, when some members of the synagogue of the Freedmen stirred up others against the new deacon, Stephen, false witnesses testified that Stephen said that Jesus will change the customs that Moses handed on. Their fear of change was so strong they stoned Stephen, but not before he reminded them that their ancestor Abraham, a man of great faith, drastically changed his life when he trusted God and left his country as God directed him. Just as Abraham adjusted to a new life, so can we. What does Jesus teach us? It is that worry doesn't accomplish much, for change is inevitable, and to trust in God. May this be our prayer and resolution for 2021.
